### 1. Definitions and Interpretation

- 1.1 The following terminology applies to these Terms and Conditions:
  - 1.1.1 "Salt and Savannah", "us", "we", refers to Salt and Savannah (Pty) Ltd, a privately owned company duly registered in South Africa under registration number 2025/874455/07, and conducting business travel and booking company;
  - 1.1.2 "Client", "you" refers to you, the person accessing this Website.
- 1.2 Any use of the above terminology or other words in the singular, plural, capitalization and/or he/she or they, are taken as interchangeable and therefore as referring to same.

### 2. Cookies
